

Cumberland County Board of Elections
Election Day Absentee Meeting
Nov 4, 2025

The Election Day Absentee Meeting was called to order by Chair Devore at 3:00 PM.

Members in attendance: Devore, Edmonds, Eldridge, Grimes, Johnson

Others in attendance: Director of Elections Angie Amaro, Deputy Director Vicki Hilburn, Staff Members Josh Dovi and Shameerah Dixon

ACTION: Member Grimes moved to approve the agenda. Seconded by Edmonds and approved unanimously.

Chair Devore gave an update on the election with early voting at 7268 votes, which is a 55% increase from the previous municipal election.

Josh Dovi shut down the absentee ballot tabulator with a count of 125, and all tapes were signed by board members.

Shameerah Dixon presented for board consideration the following 19 absentee ballots received today: 4 civilian ballots, 1 civilian ballot with ID exception form received electronically, 12 military ballots received electronically, 2 civilian overseas ballots received electronically.

The DS200 count was 0 prior to consideration of the absentee ballots approved during this meeting.

ACTION: Member Edmonds made the motion to accept the 1 civilian ballot with ID exception form received electronically. The motion was seconded by Member Johnson and approved unanimously.

ACTION: Member Eldridge made the motion to accept the 4 civilian ballots recommended by staff. The motion was seconded by Member Grimes and approved unanimously.

ACTION: Member Grimes made the motion to accept the 2 civilian overseas ballots received electronically. The motion was seconded by Member Johnson and approved unanimously.

ACTION: Member Johnson made the motion to accept the 12 military ballots received electronically. The motion was seconded by Member Edmonds and approved unanimously.


