A. Public Comment

B. Flu Shot Fees

Candi York presented a proposal to increase flu shots from their current rate to the Medicaid rate. Fees are recommended for each vaccine considering the acquisition cost of the vaccine, the Medicaid rate, 3rd party rates and the type of vaccine being administered. Our fees were set below the Medicaid rate, and therefore need to be increased to be in line with Medicaid rates. Fluzone high dose for 65 years and up were set at a current rate of \$50 and the proposed rate is \$61.00. Flublok which is for 50-64 years, was set at \$45 and the proposed rate is \$61.00. The Flu-Preservative Free for 36 months and up is set at \$19.00 and the proposed rate is \$20.00.

C. Additional Funding from the NCDHHS

Mrs. Candice York presented the Board of Health, information that the Health Department had received additional funding from the North Carolina Department of Health and Human Services to increase vaccination coverage during the COVID-19 pandemic. The Health Department will be able to provide flu vaccine at no cost to the uninsured and underinsured.
